

**PETRONAS DAGANGAN BERHAD**  
**“PETRONAS POWEROFSEVEN VIRTUAL RUN”**  
**CAMPAIGN**  
**TERMS AND CONDITIONS**

**1.0 Organiser:**

1.1 PETRONAS Dagangan Berhad (“PDB”) is the organizer of this “POWEROFSEVEN Virtual Run” (“Campaign”). This is a nationwide campaign.

1.2 Health4U Solutions Sdn Bhd (“Health4U”) via its BookDoc online platform and/or mobile application (“BookDoc”) is the Event Management solution provider appointed by PDB for this campaign.

1.3 The following terms and conditions apply in respect of this Campaign. By participating in this Campaign, you agree to be bound by these terms and conditions, including any terms which may have been amended from time to time, without limitation or qualification.

**2.0 Eligibility:**

2.1 This Campaign is open to public with Malaysian citizenship residing in Malaysia, aged eighteen (18) and above (“Participant” or “Participants”) subject to the following Terms and Conditions.

2.2 This Campaign is **OPEN to Participants** who have **BookDoc app installed on their mobile device**, except for the following category of persons who are NOT ELIGIBLE to participate in the Campaign:

- (a) Permanent/Contract employees of PETRONAS and their immediate family members specially defined as father, mother, spouses and children;
- (b) PETRONAS Station dealers and *Kru* PETRONAS and their immediate family members specially defined as father, mother, spouses and children; and
- (c) Employees of advertising and promotional agencies for PDB and their immediate family members specially defined as father, mother, spouses, and children.

2.3 In the event a Participant is found to be ineligible at any point of time during or after the Campaign Period as stated below, PDB reserves the right to disqualify the said Participant and to cancel/withdraw/recall any prizes won by the Participant, failing which, the Participant agrees and undertakes to

indemnify PDB for the costs of such prizes. PDB shall have the right to initiate any action it deems necessary against the said Participant.

- 4.2 "Package A" Participants participate by selecting the 'Paid Entry' option on BookDoc's POWEROFSEVEN Virtual Run Page and subsequently paying RM68.00 through BookDoc. **TWENTY ONE (21)** "Package A" Participants will be selected to win a Lucky Draw Prize from the 'Package A' Lucky Draw Prizes listed in Item 5.1 below
- 4.3 "Package B" Participants participate by selecting the 'Free Entry' option on BookDoc's POWEROFSEVEN Virtual Run Page. From here, a "Package B" Participant may choose to:
- a) maintain status quo; or
  - b) click on the 'Receipt Submissions' link in the description where they submit a digital picture of a valid **PETRONAS** receipt transacted during the Campaign Period; amounting to **RM30** or more purchase of the following fuel products:
    - i. PETRONAS Primax 95 with Pro-Drive,
    - ii. PETRONAS Primax 97 with Pro-Race,
    - iii. PETRONAS Dynamic Diesel Euro 5 with Pro-Drive, or

- 4.4 Receipts submitted does not guarantee acceptance of Entry or a Lucky Draw Chance. Receipts received by BookDoc will be verified on a best effort basis and needs to be visually legible to be accepted. PDB reserves the right to decide which 'Receipt Submissions' are valid or invalid.
